Communities In Schools of Spokane County provided basic needs to more than 10,000 students in four high schools, four middle schools, and four elementary schools in Airway Heights, Cheney, Medical Lake, Spokane and Spokane Valley. Basic needs include food, clothing, and school supplies. Site Coordinators identify children who are the most at-risk of academic failure, set an academic goal, with each child to develop a plan to keep the identified child from failing. The Site Coordinators broker internal and external services throughout the year, checks and documents each child's progress, and advocates for the child and their family. Due to the pandemic, we also provided food to approximately 72,000 community members between July 2020 and March 2021.
